

## **By-laws to be considered on July 22, 2013**

- a) A By-law to amend By-law No. 64-270 entitled "A By-law to establish Zoning Area No. 4 and to regulate the use of land and the character, location and use of buildings and structures therein." (Three readings – with respect to rezoning 187 First Street to allow semi-detached dwelling. Council, June 24, 2013, Item No. 6(a).)
- b) A By-law to amend By-law No. 89-304 entitled "A By-law to designate private roadways as fire routes along which no parking of vehicles is permitted". (Three readings – with respect to amendment to traffic by-law. Delegation By-law No. 2004-277, as amended.)
